The remote e-voting period begins on Tuesday, November 15, 2022 at 09:00 A.M. and ends on Thursday, November 17, 2022 at 05:00 P.M. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. Friday, November 11, 2022 may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being Friday, November 11, 2022.

#### How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

# EXPLANATORY STATEMENT UNDER SECTION 102 OF THE COMPANIES ACT, 2013 <a href="https://linear.nc.1">Item no. 1</a>

On Recommendation of the Audit Committee, the Board of Directors of the Company at their meeting held on October 15, 2022 have decided to sell the immoveable property(ies)/assets of the Company.

Accordingly, pursuant to section 180(1)(a) of the Companies Act, 2013, members of the Company are requested to note that their consent to the Board is being sought by way of a Special Resolution to sell and transfer the Company's investments (both present and future), tangible/intangible assets, immovable/movable property/ies/undertaking/s as the case may be, as may be determined by the Board, for such consideration and on such terms and conditions as the Board may deem fit in the best interest of the Company. Hence, your Directors recommend passing of the said resolution as a special resolution.

None of the Directors or key managerial personnel of the Company or their relatives are concerned or interested in the proposed resolution.
